Zhihu Inc. (ZH) has announced a 1-for-6 reverse stock split. As a result of the reverse stock split, each ZH American Depositary Share will be converted into the right to receive approximately 0.166667 (New) Zhihu Inc. American Depositary Shares. The reverse stock split will become effective before the market open on May 10, 2024. Cash will be paid in lieu of fractional shares.

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Pricing

Until the cash in lieu amount is determined, the underlying price for ZH1 will be determined as follows:

$$\text{ZH1} = 0.166667 (\text{ZH})$$

Delayed Settlement

The ZH component of the ZH1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the ZH1 deliverable until the cash in lieu of fractional ZH Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
